



## Key features

#### Alert your employees to their outstanding policies

Your organisation's policies are deployed to your staff through a web based interface which can be customised to match your organisation's branding. The policies can be grouped into convenient categories, and a simple 'traffic light' system shows your staff which policies they need to review and accept.

Policies are configurable, meaning that people only see the policies relevant to their roles. Employees can be automatically alerted via email of any new or overdue policies, and the content of these e-mails is entirely customisable by managers.





### Provide resources that support the policy message such as training videos and key messages

A policy can be comprised of just a single document or it can have other associated documentation displayed alongside it so that all related information is available in one place.

In addition, training videos can be uploaded, appendices attached and forms can be linked to. Key messages displayed after viewing a policy allow the important points to be summarised to aid understanding.

### Confirm employee understanding of your policies through question sections

Prior to accepting a policy there is an option for an employee to be asked a series of questions related to the policy or procedure they have just read. Failing to correctly answer the required number of questions (or even failing to pass the quiz a set number of times if the option is given to have multiple attempts) will result in the policy administration team being alerted and the employee will be unable to accept the policy.

## An 'at a glance' status of policy acceptance across your entire organisation
