PARTICIPANTS TAKE PART AT THEIR OWN RISK. RSM PALEA LAURI GERLA (by means of its subsidiary RSM ITALY TAX & ADVISORY S.r.l.) and RSM SOCIETÀ DI REVISIONE E ORGANIZZAZIONE CONTABILE (“Tournament Organisers”) WILL NOT BE RESPONSIBLE FOR DEATH, PERSONAL INJURY OR LOSS OR DAMAGE OF PROPERTY OTHER THAN AS A RESULT OF NEGLIGENCE ON THE PART OF THE TOURNAMENT ORGANIZERS.

The RSM Football Tournament is an amatorial event with recreational purposes (Italian “*attività ludico-ricreativa*”) held occasionally.

Tournament Organisers have arranged for the football tournament to take place at the CIT TURIN LDE ASD in Turin.

A medical doctor, a physiotherapist and an ambulance will be present for the entire duration of the tournament to provide first aid for injuries caused during the matches. Please be informed that the closest hospital with an emergency room is located 1,4 km away from the tournament venue.

Tournament Organisers are not to be held liable for players’ illnesses or injuries obtained before the tournament, nor for illnesses or injuries arising during the tournament but caused by pre-existent illnesses or injuries.

Despite its non-competitive character, **organizers highly recommend that all players should undergo medical examinations before arriving to Turin and be certified by their doctors as being in good health and physically fit for five-a-side football.**

EACH INDIVIDUAL PLAYER MUST BE COVERED BY HIS/HER OWN ACCIDENT AND MEDICAL INSURANCE.

Participants must be dressed appropriately and Tournament Organizers reserve the right to refuse admittance to any participant who is not appropriately dressed.

It is the aim of the Tournament Organizers to provide you with an enjoyable and safe experience. Therefore, Tournament Organizers have taken precautions to provide proper venue and equipment (where appropriate); but at the same time it is impossible to guarantee absolute safety. **Consequently, you must understand, and agree to assume, a shared responsibility for your safety.**

You must bring to the attention of the Tournament Organizers any situation that you perceive as potentially hazardous to yourself.

The tournament regulations have been made available to all participants before September 2nd, 2017 (tournament day). Participation in the tournament is to be interpreted as teams and players accepting the regulations. A specific acknowledgement of article 4 (commas a, b and c) of the Tournament Regulations will be requested to each participant by means of an online form before their arrival in Turin.

Finally, please confirm with your signature that you have read this information and understand your responsibility as a participant, and that you assume all of the risks incidental to attending the Tournament. Further, you confirm that you will follow instructions and directions given by the organizers, act prudently, and use good judgment.
