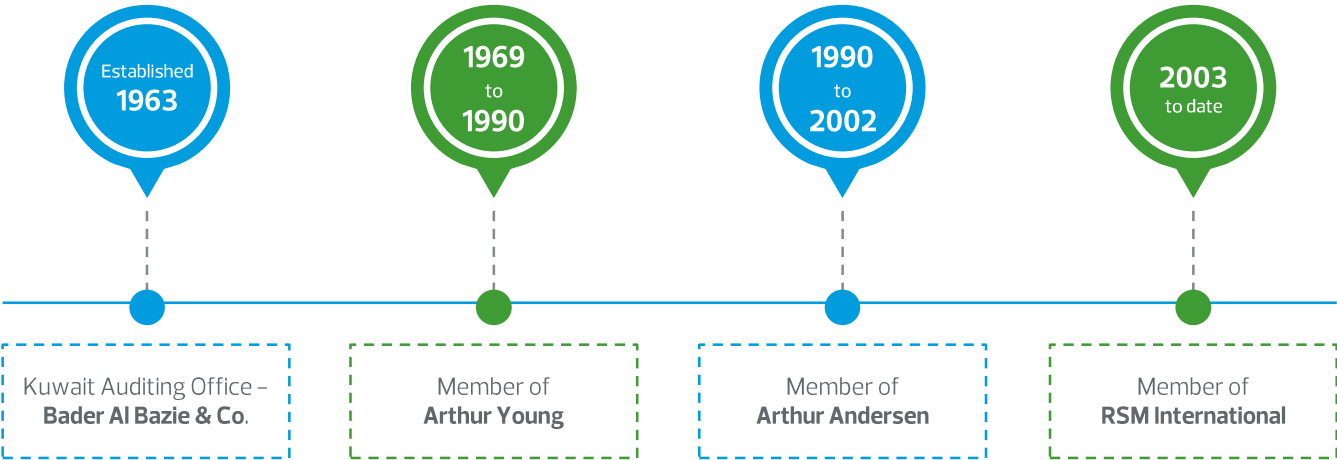


# FACT SHEET

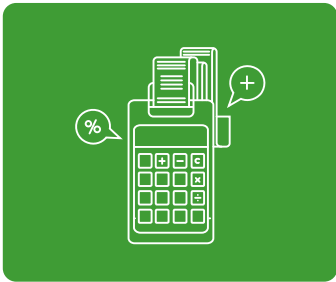
