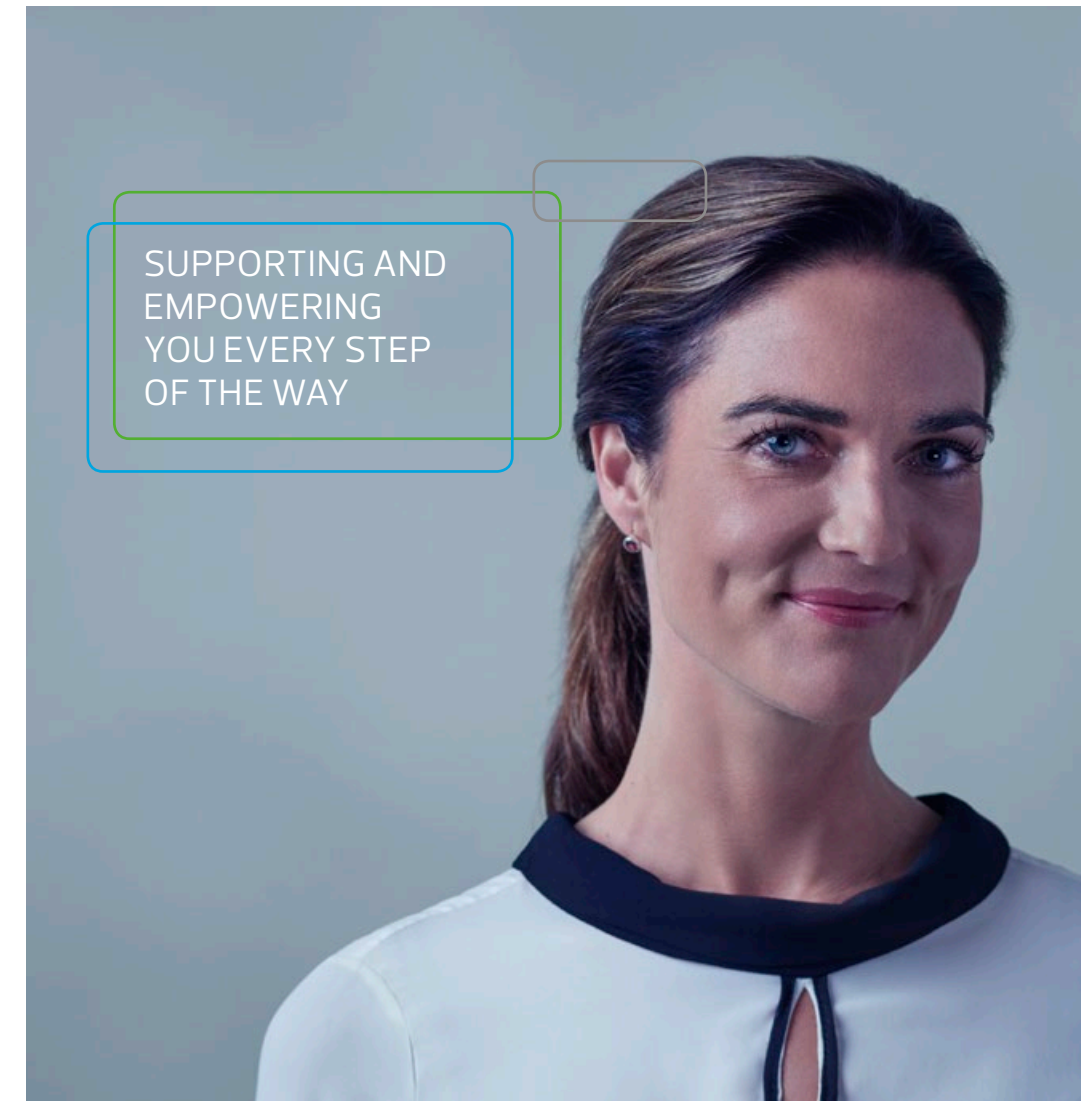

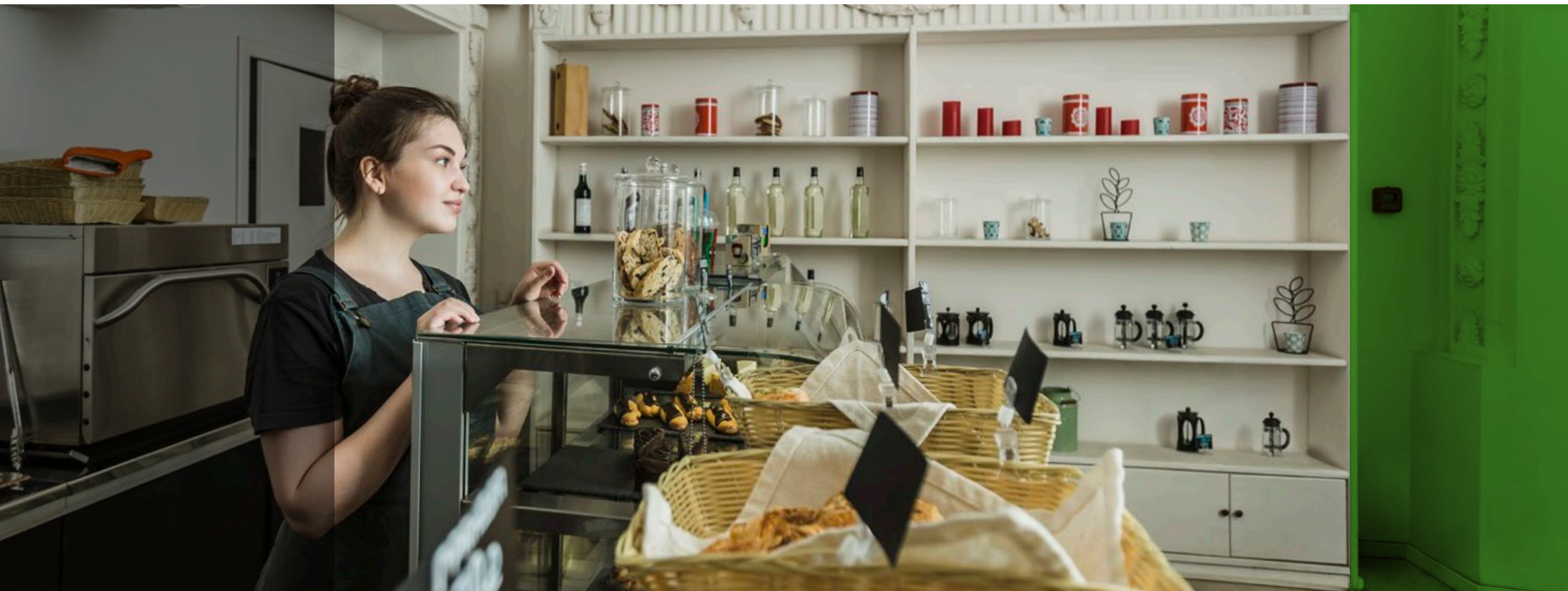

Why a consultancy scheme?

Eligible Actions

External consultancy services procured to support the decision taking process by assessing and evaluating:

- The potential of the Undertaking to take on proposed investment initiatives aimed at the potential

future business growth of the Undertaking, and at rendering it more competitive, resulting in the development of a Business Plan or Feasibility Study;

or

- The potential of re-engineering the organisation and operations, or the processes and systems of the undertaking aimed at rendering it more efficient, resulting in the development of an Organisation and Operations Review or Process and Systems Review.
