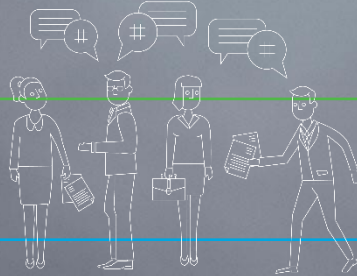

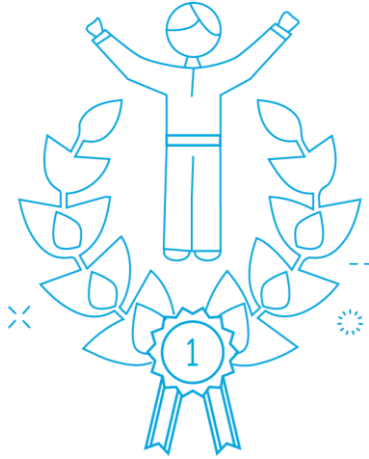


Knowledge

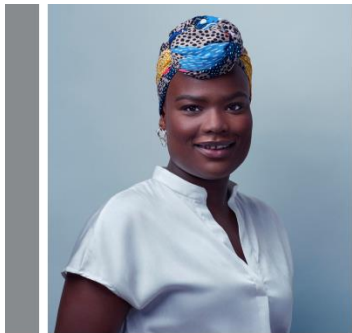


Conclusion
