Regulatory and procedural framework for foreign loans, FX risk, and loan restructuring

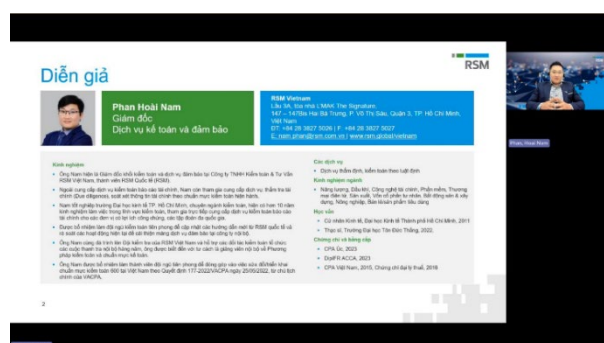

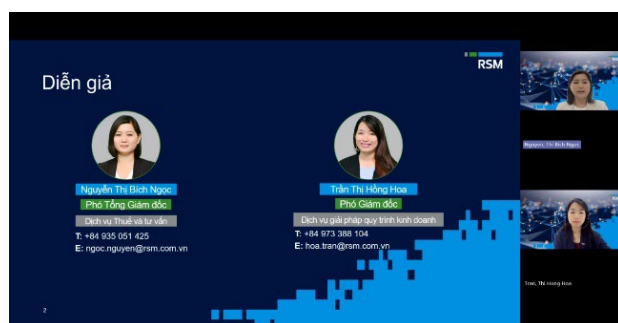
