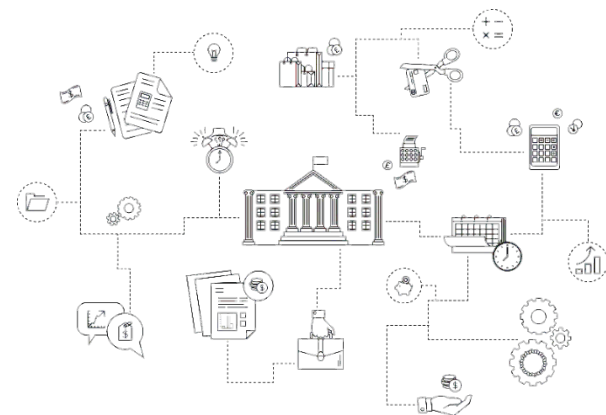

For individuals who directly carry out the PIT Finalization

- According to the notice of Ho Chi Minh City Tax Department on 02 March 2020, the deadline for submitting PIT finalization dossiers for 2019 is 30 March 2020, particularly for the case of overpayment, requesting for tax refund or tax offset, the PIT finalization dossiers may be submitted after 30 March 2020.
- In 2020, besides the traditional support channels, Ho Chi Minh City Tax Department applies the method of supporting taxpayers to carry out the PIT finalization via websites, Facebook, online video lectures.
- In addition, to ensure the prevention of Covid-19 epidemic, Ho Chi Minh City Tax Department and all 24 Tax Departments in Districts will not prepare facilities and equipment at headquarters to support taxpayers to make tax declarations as every year. Taxpayers must make the PIT declaration return at home or at their company and submit online via the website <http://thuedientu.gdt.gov.vn>. Detailed guidance of making PIT declaration return will be posted via website, Fan page of Tax Department so that taxpayers could make the PIT declaration return by themselves.
- For the case of lodging PIT finalization dossiers in paper, Tax Department encourages to send by post or make an appointment by online registration with Tax Authority to submit directly.
